However, let's take a little time to look at some of the qualitative aspects in bringing value to your Crime Stoppers organization. Almost everyone likes to be acknowledged and recognized for a job well done. This certainly starts at a young age such as when your child arrives home with a great report card and a smile from ear to ear! Back when I was a kid, I was 'rewarded' with a dollar for every 'A' on my report card. Okay, so I might be dating myself, however, the point is there was some recognition and a reward for work well done.

This will help engage your law-enforcement community, as well as the media, in bringing recognition and acknowledgment to the lawenforcement the Crime agencies and Stoppers organization.

From a community perspective, I have seen Crime Stoppers organizations take on celebrations recognizing momentous occasions such as every five-year This may be done in conjunction with anniversaries. another community event, but passing out cake, ice cream and some beverages to community members along with pens or other trinkets from Crime Stoppers brings the awareness to the community during this celebratory time. And guess what, you can share your great statistics as well as how we are working to make the community more safe and secure for all.

Racine Man Accused of 2016 Murder Involving Delivery Driver

A Racine man has been charged for the 2016 murder of a delivery driver.

Alex T. Adams, 28, is accused of shooting James Norris, 37, a delivery driver for Super Steaks and Lemonade during a **botched robbery** on the 3900 block of Green Street.



Norris was the father of four children and his wife Stacy is blind

Officers with the Racine Police Department were tipped off to Adams as a potential suspect through Racine County Crime Stoppers, according to a criminal complaint.

A witness saw Adams with a pistol after the murder the night

of March 25, 2016. Adams had apparently asked the witness to join him in robberies in the past.

Two days after the murder, Adams went to another Racine man and gave him a .38 revolver as well as some ammunition. Adams allegedly told the man,: "I had to shoot him," and "I wasn't trying to do it, it just happened."

A firearms expert confirmed told police the gun was used in the murder of the delivery driver.

During the investigation, police also recovered security footage from Walmart on 3049 S. Oaks Road, shows Adams purchasing the kind of ammunition he gave to the man to hide.

Adams was already detained after being arrested on another warrant. He is charged with first degree intentional homicide and armed robbery.

Juvenile Referred in Devils Lake Damage Case

Vandalism at Devils Lake

A 16 year old juvenile from Onalaska, WI has been referred to juvenile court in connection to the numerous acts of vandalism involving spray paint graffiti from Aug 10th 2016. Devil's Lake officials from the DNR reported that the main entrance sign leading to the North Shore of the park had been painted over with satanic symbols. Upon further investigation, numerous road signs in the area and other structures in the park were also spray painted causing extensive damage.

Working through Sauk County Crime Stoppers, the Sauk County Sheriff's Office received a number of tips and information regarding the incident. Sheriff's Detectives interviewed a number of individuals in LaCrosse County and served a search warrant in the City of Onalaska during this investigation.

The 16 year old suspect was vacationing with relatives in the area during the time of the vandalism and it is unknown at this time if others will be charged. The Sauk County Sheriff's Office would like to remind citizens that their input and information in matters like these are vital to their investigations.

Other cases solved by citizen involvement and tips

Recently, 4 other incidents where anonymous tips were received helped in the arrest of 3 persons who were wanted by Sauk County authorities due to outstanding charges/arrest warrants, and another tip resulted in a narcotics arrest at the Reedsburg High School. Sauk County Crime Stoppers is also working with the Sauk Prairie Police Department regarding numerous acts of criminal damage to government and personal property including road signs, mail boxes and slashed tires.

Two Arrested, Numerous Drugs Seized In Sauk County Drug Bust

From Detective J. Hannagan—Took this information through Tipsoft and did a lot of communication with the tipster through our narcotics team leading to the following arrests.

BARABOO (WKOW) -- Two people have been arrested, and drugs, cash, and paraphernalia have been seized following a search warrant executed in the City of Baraboo.

The Sauk County Drug Task Force says they obtained and executed the search warrant as a result of on-going drug investigations.

At the residence at 309 Mulberry Street in Baraboo, drugs, cash, and paraphernalia were seized. This included more than 200 grams of Marijuana, 11.6 grams of LSD, 1.1 grams of Cocaine, 2.3 grams of Crack Cocaine, 1.8 grams of Meth, several grams of DMT, and \$19,590 in cash.

51-year-old William Zierdt, of Baraboo and 42-year-old Carrie Christofano of Baraboo were arrested. They face multiple charges, including possession of drug paraphernalia, maintaining a drug trafficking place, and manufacture/delivery of a controlled substance within 1,000 feet of a public school.

While officers were serving the warrant, the Al. Behrman Elementary School was placed into Administrative hold to ensure the safety of students and staff.

The investigation is ongoing.
